

FULL COPYRIGHT TRANSFER AGREEMENT

This Copyright Transfer Agreement (the "**Agreement**") is entered into between:

1. Subject of the Agreement & Copyright Assignment

- **Assignment & Outright Sale:** Upon payment of the agreed sum of € _____ (or as detailed in the accepted invoice), Author hereby sells, transfers, and assigns to Publisher all rights, title, and interest—including full and exclusive underlying copyright—in the Work worldwide in all languages (including English and French) in perpetuity.
- **Scope of Rights:** Publisher shall hold sole legal ownership to publish, translate, adapt, copy, reprint, license, distribute, market, derivative-work, or sublicense the Work in print, digital, electronic, database, or any other media format now known or hereafter created.
- **Publisher Ownership:** Publisher owns all right and title to original drafts, translations, compilations, and derivative works created from the Work.

2. Limitations on Reproduction by Author

Because this is an outright purchase of full copyright, **Author retains no independent right to reproduce, publish, host, or distribute the Work.**

- **Prior Written Permission Required:** Author may not republish, distribute, upload to personal/institutional websites, or include the Work (in whole or in part) in any future books, compilations, lecture notes, or external publications without obtaining **prior express written permission** from the Publisher.
- **Permitted Personal Evaluation Copy:** Author is granted the non-exclusive right to provide a private, digital copy directly to prospective employers or clients solely for personal portfolio evaluation of the Author's freelancing capabilities.
- **Mandatory Copyright Notice:** Any reproduction authorized in writing by Publisher must prominently display:
